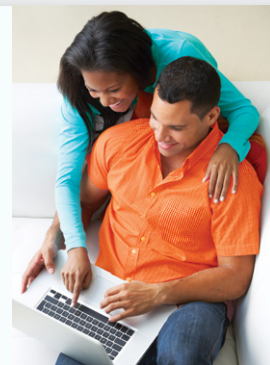


LAUNCH OFFERS RELIEF LOAN

In an effort to assist our members who may be in need of funds due to COVID-19, Launch is offering the Relief Loan for members who qualify.

Here are the details for those who wish to apply for the loan

- Interest rate of 3.99% ■ Maximum term 36 months
- Loan amount \$500 to \$5,000
- Loan special will be from March 18th to April 30th, 2020
- Relief Loan cannot be used to refinance or consolidate existing loans
- Launch FCU membership is required. Must have been a member as of March 16th, 2020
- No existing delinquent loans with Launch FCU ■ One Relief Loan per household.
- Deadline to apply for the special Relief Loan is April 30, 2020

*APR = Annual Percentage Rate. Loans subject to credit approval. Payment and term affected by amount financed. Minimum loan amount \$500; maximum amount \$5,000. (Payment example: monthly payments on a loan with a term of 12 months at 3.99% APR would be approximately \$85.15 per \$1,000 borrowed.) New money only; no internal refinances. Savings account required for loan; must be opened on or prior to March 16, 2020. Cannot be combined with any other offer; offer may end at any time and without notice.

The Treasurer of the Launch Board of Directors, Dominic Morgese, closely inspected the strength and financial security of the credit union for the Annual Report. After comparing industry standard soundness markers, he concluded that Launch is exceptionally well-funded and stable. He noted:

"The credit union achieved solid financial performance in 2019. For the year, Launch FCU posted a net income of almost \$4 million, maintained a liquidity ratio of over 10% and increased total loans by almost \$80 million. Bottom-line, your credit union remains one of the strongest in the nation and continues to receive the highest possible rating of 5-Stars from Bauer Financial, an independent firm rating banks and credit unions nationwide. Furthermore, Launch's net worth ratio, a key measure of financial strength, ended the year at 12.7%, well above the peer average of 11.3%."

Launch continues to be a strong and substantial financial institution. We are proud to be your credit union, and to serve your needs.
