In accordance with Credit Union bylaws, it is the duty of the Nominating Committee to nominate at least one individual for each vacancy on the Credit Union Board of Directors. For the year 2023, there are three vacancies to be filled on our Board of Directors. Members on the Board of Directors serve on a volunteer basis.

The Nominating Committee has chosen the following three members: Dominic Morgese, Eric Ostarly, and Dan Sicchio.

If you were not appointed by the Nominating Committee, you may run by petition for the Board of Directors. A form may be obtained from any branch of Launch CU. Submit the completed form along with signatures of at least 2% of the eligible-to-vote members (at least 18 years of age and in good standing with Launch CU). These signatures must be submitted no later than November 15, 2022.
